

## 30th Annual WVNEC Symposium Communication in Ethics Consultation

May 17, 2017 Stonewall Resort Roanoke, WV





#### **Course Description**

This symposium marks the 30th anniversary of WVNEC! Keynote speaker, Martin L. Smith, STD, director of one of the largest ethics consultation services in the country at the Cleveland Clinic, will provide a 30-year retrospective on ethics consultation in the US and point to its future. This future includes professionalization of ethics consultants with licensure or certification. Dr. Smith will discuss the impetus for this change and the likely processes by which this will occur. As in past WVNEC symposia, multiple speakers will present cases and approaches to increase participants' knowledge of and skills in ethics consultation. This symposium will also feature the ever popular opening case presentation with panel and audience participation and setting-specific breakout groups to discuss challenging cases.

#### Objectives

At the completion of this conference, participants should be able to . . .

- 1. describe what the national movement toward professionalization of ethics consultation means for those who do ethics consults in West Virginia;
- 2. apply communication approaches and knowledge of West Virginia law to refine their ethics consultation skills;
- 3. review the past 30 years of ethics consultation as a lens to see what the major issues in ethics case consultation will be in the future; and
- 4. analyze challenging ethics consultation cases to sharpen their skills as ethics consultants.

#### **Course Credits**

# **Course Faculty**



**Carl Grey, MD** - Assistant Professor, West Virginia University School of Medicine, Section of Supportive Care and Associate Driector of the WVU Center for Health Ethics and Law. Dr. Grey is a geriatrician and supportive care physician who treats these patients in both the inpatient and outpatient settings. He is the Co-Director of the second year medical student required Health Care Ethics Course. He is a member of the WVU Hospital Ethics Committee and has attended both the Intensive Bioethics Course at Georgetown and the Summer Seminar in Health Care Ethics at the University of Washington School of Medicine.







**Alvin Moss, MD, FACP, FAAHPM -** Professor of Medicine, West Virginia University School of Medicine; Chair, WVUH Ethics Committee; Director, WV Network of Ethics Committees. Dr. Moss is the Medical Director of the WVU Hospital Supportive Care team. He has performed ethics consults for more than 25 years and taught about ethics consultation at the state and national level for more than 20 years. His research includes innovations to improve advance care planning and end-of-life care.

**Sandra Price**, **JD** - Risk Manager for the Robert C. Byrd Health Sciences Center at WVU. Sandy regularly presents educational programs on risk management, documentation and liability, informed consent, communication, confidentiality, and related legal issues to the students, residents and faculty in the clinical departments of the Health Sciences Center. Additionally, she serves as an ex-officio member of the Advisory Committee for the WVNEC and teaches Health Care Torts at the West Virginia University College of Law.

Valerie Satkoske, MSW, PhD - Director of Ethics for Wheeling Hospital and an ethics consultant for The Diocese of Wheeling-Charleston and the WV Rural Emergency Trauma Institute. She is an Assistant Professor in the Department of Medical Education at WVU School of Medicine and Associate Director of the WVU Center for Health Ethics and Law. She sits on the ethics committees of Wheeling Hospital and WVU Hospitals. Additionally, she is core faculty in the University of Pittsburgh Center for Bioethics and Health Law and is an affiliate faculty member of the University of Pittsburgh Consortium Ethics Program.



**Martin Smith, STD** - Director, Clinical Ethics, the Department of Bioethics, the Cleveland Clinic. He received his doctoral degree in theology from the Gregorian University in Rome, Italy. He served as President of the Bioethics Network of Ohio (BENO) from 1995-2000. He continues as a member of BENO's Board of Trustees. In 2014 he was elected to the Board of Trustees of the American Society for Bioethics and Humanities (ASBH). He has written numerous articles on a wide range of topics including ethics consultation and ethics committees.
